Report of the Superintendent of Schools

To the Honorable School Committee, Selectmen, and
Citizens of North Kennebunkport:

Ladies and Gentlemen :—

It is with unusual pleasure that I submit this, my twelfth annual report of schools, for your approval.

Your attention is called to the statistical data appended to this report. The school census shows an increase in number of pupils in North Kennebunkport over the report of last year. This census includes pupils between the 5th and 21st years of age April 1st. While the census increased, the enrollment in the local schools fell off slightly. At the same time the elementary tuition pupils increased four or five pupils and the secondary tuition pupils increased by twelve. The authorities of Kennebunkport raised the tuition rate to \$100 per pupil. You may expect, therefore, an increased tuition charge over previous years.

The State compiles many types of school statistics. These statistics are compiled as of June 30th of each year. Costs of municipalities per tax dollar are available for every town and plantation in the State. This enables the interested citizen to compare his community with the State as a whole. The statistics are especially interesting- to the town of North Kennebunkport this year. They indicate that you are entitled to share in the State subsidy known as the equalization fund.

This equalization fund is a sum of money distributed to those towns whose tax rates average above the general average for the State as a whole. The average

school rate this past year was .01171 while your school rate was .01459. At the same time the average municipal rate was .05535 while your town rate was .059.

The allotment of the equalization fund is as follows: \$92.00 for lengthening of school year and \$100 to be expended in a permanent library and equipment facilities. This special fund is to be expended under the direction and consent of the State Department of Education with concurrence of the local Superintending School Committee. Your schools will close this school year June 4th due to the- extra week made possible by this special fund.

It would seem to me to be desirable that the citizens of the town might well increase the appropriations for textbooks since the amount of money used for the six schools over a period of years has been woefully inadequate. The lack in some classes has been shameful. In view of the extra help afforded by the State, if the textbook situation in North Kennebunkport could gradually be brought up to date, I think a considerable stride would be made educationally for the children of the town. Library and textbook work are closely related in modern school effort.

REPAIRS

At the time the town opened the extra school at Burnham, the schools used, temporarily, a common toilet connected with the main room. This arrangement proved of considerable annoyance and interrupted school considerably with so many pupils passing from one room to another between sessions. This arrangement was contrary to State Law and was remedied by installing a toilet in one corner of the new wood shed at Burnham School. The repairs this past year were under the direction and supervision of Mr. Andrew Lux. Your school buildings need paint and some general repairs. Some of

the schoolrooms are very dark and should be lighted up by fresh coats of light tinted paints. This is almost a necessity as some children must be unnecessarily impairing their eyesight.

The blackboards are all but impossible to use. They cannot be used for class purposes without impairment of the sight of children subjected to this strain. This coming year the interior of the schools should have attention with an aim of remedying these needs.

The outside conditions of the school buildings are suffering for need of paint. The flagpole at Iron Bridge is now in a dangerous condition and should be taken down at once. It should be replaced so that a flag can be flown from this school yard when school is in session to comply with school law. The need of a flagpole at Irving School has been neglected since the opening of the school. We have at times been promised a flagpole by nearby neighbors but for one reason or another this did not materialize.

DEPARTMENTAL TEACHING

The departmental teaching has this advantage over the other methods. Namely, it tends to allocate to each teacher the subject most interesting to her and in which she has the greatest facility of presentation. This is in my estimation highly desirable. The pupils profit almost in direct ratio to the teacher's interest and facility of presentation. The teachers themselves report that results now obtained are unquestionably greater than under the less flexible system. Our grading now is on textbook level. We try to accomplish work in the fundamental subjects on the grade level thought by the best educators as standard. Our greatest handicap is the lack of sufficient textbooks for the work in hand.

May I say, in conclusion, that the greatest cooperation

has existed in all phases of the school work in your town with which I have come in contact.

The teachers have made progress in every phase of their work. The school committee have loyally supported the school program in every way. They merit your full support and commendation.

I herewith submit the annual report of the York County Nurse for the school and other health work accomplished in North Kennebunkport during the year beginning January 1, 1936, and ending December 31 1936.

During the months of January and February the nurse made arrangements and furnished transportation for one adult and six children to a clinic in Portland. Later trips to the dentist were made with these same patients. Home visits were made on children ill with whooping cough and other school children in need of corrective work.

Numerous home visits were made during the summer months on children needing corrective work done.

She has also, at the request of some of the teachers, made a more complete inspection at the first visit, in order that the teacher might complete her health habit program.

WARRANT

For Town Meeting, March 1, 1937

STATE OF MAINE

County of York, ss.

To Florence R. Hayes, Constable of the Town of North
Kennebunkport, in said County, GREETING:•

In the name of the State of Maine, you are hereby re-
quired to notify and warn the inhabitants of said Town
of North Kennebunkport, qualified by law to vote in:
town affairs, to assemble at the Town House, in said
town, on the 1st day of March, 1937, at ten o'clock in the
forenoon, to act on the following' articles, to wit:

Article 1. To choose a moderator to preside at said
meeting.

Art. 2. To see if the town will vote to dispense with
the check list at this meeting.

Art. 3. To choose all necessary town officers for the
ensuing-year.

Art. 4. To see what sum of money the town will vote
to raise for the support of common schools.

Art. 5. To see what sum of money the town will vote
to raise for high school tuition.

Art. 6. To see what sum of money the town will vote
to raise for repairs and insurance on school buildings.

Art. 7. To see what sum of money the town will vote
to raise for free textbooks.

Art. 8. To see what sum of money the town will vote to raise for school supplies.

Art. 9. To see what sum of money the town will vote to raise for salary of superintendent of schools.

Art. 10. To see what action the town will take with regard to separating the common road and bridge appropriation into two parts, namely, a common road fund and a fund for the repair of bridges, a separate appropriation to be made for each fund.

Art. 11. To see what sum of money the town will vote to raise for the repair of roads and bridge.

Art. 13. To see what sum of money shall be paid to the road commissioners per day for their services, and fix the price per hour for labor on the highways.

Art. 13. To see if the town will vote to divide the common road appropriation between its road commissioners on a mileage basis.

Art. 14. To see if the town will vote "yes" or "no" on the question of raising and appropriating money necessary to entitle the town to State aid, as provided in Section 20, Chapter 38, Revised Statutes of 1930.

Art. 15. To see what sum the town will vote to raise and appropriate for the improvement of the section of State aid road as outlined in report of State Highway Commission (in addition to amounts regularly raised for the care of ways, highways and bridges), under provisions of Section 19, Chapter 28, Revised Statutes of 1930, or under Section 3, Chapter 175, Public Laws of 1933.

Art. 16. To see if the town will vote to raise a sum of money to cut and destroy all bushes on State highway, State aid, and third class roads, to comply with Chapter 145, Public Laws of 1927, and if so, how much.

Art. 17. To see if the town will vote to raise the sum of four hundred and thirty dollars and thirty-four cents to repair and maintain third class roads, to comply with Sections 43 to 47, Chapter 28, Revised Statutes of 1930, as amended by Chapter 175, Public Laws of 1933.

Art. 18. To see if the town will raise a sum of money to pay bond and interest coming due this year.

Art. 19. To see what sum the town will raise for the removal of snow.

Art. 20. To see what sum the town will raise for the support of poor.

Art. 21. To see what sum the town will raise for the contingent fund.

Art. 22. To see if the town will vote to raise a sum of money to provide for the services of a public health nurse, or take action thereon. This action is made legal by the Maine Legislature of 1925, Section 58, Chapter 140, Public Laws of 1925.

Art. 23. To see if the town will authorize the treasurer to execute quit claim deeds of the following:

To Federal Land Bank of Springfield to cover town's claim on the C. C. Day property,

To York Building & Loan Association to cover town's claim on the Edward L. Tibbetts property.

To Jacob Agger (Morin Brick Co. of Lewiston, Me.) to cover town's claim on J. B. Lunt (Maine Brick Co.) property.

To Arthur J. Jones to cover town's claim on the property of Arthur J. Jones.

To Albert Parenteau to cover the town's claim on the George Parenteau property.

Art. 24. To see what sum the town will vote to pay for the collection of taxes.

Art. 25. To see if the, town will, vote that for the purpose of procuring a temporary loan to and for the use of the, Town of, North Kennebunkport, to pay the indebtedness of said town, due or to become due during the present, municipal year, to be paid out of money raised by taxation during the present municipal year, the town treasurer be and is hereby authorized and directed to borrow from time to time a sum or sums not exceeding in the aggregate ten thousand dollars, and to execute and deliver the note or notes of the town therefor, signed by the town treasurer and countersigned by the municipal officers of the town.

Art. 26. That this town committee representing the York County Tercentenary Commission with the approval of the Board of Selectmen as to location may erect historical markers which the Commission will furnish or authorize, without cost to the town, on town property and along the traveled portions of its highways.

Art. 27. To see what action the town will take regarding the abatement of taxes on J. B. Lunt property.

Art. 28. To act on any further business that may come before this meeting.

The selectmen hereby give notice that they will be in session at the Town House at nine o'clock in the forenoon of the day of said meeting, for the purpose of revising and correcting list of voters.
