REPORT

OF THE

Superintendent of Schools

To the Honorable School Committee, Board of Selectmen, and
Citizens of North Kennebunkport.

Ladies and Gentlemen:

It gives me unusual pleasure to submit for your consideration my seventh annual report of schools. In past reports, I have presented those aspects of your schools which, in my judgment, best revealed the work which the teachers are doing and the goals attained by your children. This practical method I propose to follow in this report.

THE IRVING SCHOOL

The discussions regarding the opening of the Irving School resulted in two successive Town Meetings—August 28, September 8---being called in which the citizens of North Kennebunkport made a rather searching enquiry into the needs of this district.

A petition was signed by the residents of Irving district asking that a school be opened which would accommodate pupils reaching school age and those pupils of North Kennebunkport who formerly attended the Upper Alewife School. This petition was considered at length.

The unfavorable transportation conditions between the Irving district and the Durell School led the citizens to grant the request for a school in the Irving district.

In my report of February 16, 1931, it was pointed out that, should the citizens of North Kennebunkport vote to open the Irving School, it would first be necessary to comply with the State law in providing an attached toilet. A special meeting of the Superintending School Committee was called September 8th, immediately at the close of the special Town Meeting. Mr. Alton Benson, Mr. Ernest A. Ricker and Mr. Fred Durell, officers of the town, were present at this meeting. The situation was considered from all angles in the light of the expressed will-of-the-town that Irving School be opened immediately. Schools in North Kennebunkport were to open the Fall term, September 14. It was apparent that, if the will-of-the-citizens as expressed in Town Meeting was to be carried out in opening of the Irving School, no time could be lost in attaching the necessary toilet facilities as required by statute.

The School Committee and representatives of the town authorized Mr. Ernest A. Ricker to have charge of the repair and construction work at the school.

The Superintendent was instructed, in accordance with the vote of Town meeting of September 8th, by the Superintending School Committee, to procure a teacher for the school. A stove had to be purchased and set up, some desks provided, text books and supplies ordered. This was accomplished with dispatch.

I made almost daily visits to the Irving district during the period of preparation for opening of this school, and during the past Fall term made eight supervisory visits in order to assure a successful opening.

The outlay at the Irving School was done at minimum cost for the amount of work accomplished. A very excellent and commendable spirit has been manifest by all who have had any part in preparing the school building for the opening of school. The building is comfortable and sanitary. It was cleaned by the neighbors, the work being done free of charge. The Walker brothers did a splendid job in hauling in loam around the underpinning of the building which was also done free of charge. I wish to express personal satisfaction with this fine spirit.

There is need of a flag pole. This should be attended to in the spring so the flag may be displayed at this school. When the flag pole is set, it should be placed between oak shoulders so that periodic inspection for safety and repainting can be done with minimum of expense and maximum of efficiency.

IRON BRIDGE SCHOOL

The Iron Bridge School has made steady growth since the town voted to open it in April, 1929. It was little thought 'at that time that this school would have to enlarge its seating capacity to accommodate new pupils of this district for a long time, but every seat was filled this fall, 'and when three extra pupils applied for entrance, the School Committee had, before accepting them as pupils, to provide three desks and seats. There are fourteen pupils registered at this school at the present time. The progress made has been commendable. It appears that the enrollment will grow in this district.

THE BURNHAM SCHOOL

The Burnham School has the largest enrollment in years. Several new seats had to be arranged for to accommodate the enrollment. There are thirty-five pupils in attendance at the school, representing nearly all grades and is a heavy teaching load. I wish to state that the work as now conducted by the teacher, Mrs.

Sarah Talbot, is capably and efficiently handled. Only a thoroughly efficient teacher could satisfactorily handle so large a rural school under modern standards.

DURELL SCHOOL

The Durell School has an enrollment, at the present time, of thirteen pupils. This school has not been as greatly affected by the opening of the Irving School as anticipated. The average attendance has been good although there has been some sickness among the pupils. However, it has been of short duration and of little consequence. The same fine work of the past has been maintained.

NORTH CHAPEL SCHOOL

The North Chapel School has an enrollment of twelve pupils. There has been a considerable moving about of some of the pupils of this school. It is due, no doubt, in large part to the depression. A real standard is being striven for in this school and the results have justified the effort.

There are certain outstanding events in this year's work in the North Kennebunkport schools which are especially commendable. The Plan Books submitted by the teachers embracing the daily plans in each subject have each year been more definite and comprehensive. This marks the professional growth of your teaching staff and serves to indicate the real wealth of material which they seek to impart to your pupils day by day.

The examination questions have also indicated growth in school methods and have reflected in their precision and grasp the care with which the teachers prepare their work. Some of your grade work in the fundamentals is fully abreast of the work often required of single specialized grades.

There is another matter which it gives me pleasure to record at this time. The teaching staff of North Kennebunkport are 100% members of the National Education Association, the largest teachers' association in America and the world. Our Union will be 100 but North Kennebunkport was the first town in the Union to be so recorded. This is a matter for pride and congratulation since Miss Florence Hale, a Maine teacher, has this year been elected head of the organization. This is indeed a high privilege which the teachers of your schools have participated in.

There is one more thing which is perhaps of more importance than any other single item, and a particularly happy occurrence for me to relate, which is the regular and unfailing attendance of your teachers at each and every teachers' meeting held in Saco. These meetings have been made a source of growth and profit, and

in my judgment, helped immensely in raising the work of your schools to commendable standard.

FINAINCIAL STATEMENT

The School Committee wishes to call your attention to the balances and overdrafts in your school appropriation. You will recall that no extra appropriations were made at the special sessions of the Town Meetings when the School Committee were authorized to open the Irving School. The financial statement appended to this report is, therefore, the more remarkable since it contains the special expenditures for the Irving School. You will see that this work was very economically done. Indeed a careful study of the expenditures will reveal that this work has been accomplished with a minimum of expenditure compatible with the work in hand.

The repair work and cleaning of the schools during the summer was done in an efficient manner and included many items. The underpinning at the Burnham School should be looked after, as it is, at the present time, in bad shape. It seems likely that the extra room at Burnham may, in the near future, be occupied as a class room. There is every indication that the rural sections will continue to fill up with incoming population if the depression should continue for any considerable time.

I wish to express my personal gratification with the unbounded confidence and good-will accorded me by the parents and electorate of the Town. This is a tribute which I highly prize. The teachers are loyal with a devoted friendship seldom seen in supervision these days. This is an added joy which I prize as a supervisory asset. The selectmen and other officers of the town have been splendid to work with and helpful in all school matters.

In closing I wish to mention the high regard and splendid cooperation which I have had during the year from the School Committee. They have approached every school problem with a breadth of vision and a splendid courage which stands out as a bright and an inspiring experience in my supervision of this Union during the past year.

The customary report of statistics are included at the close of this report. A study of the census is given in detail.

the Irving School.

Article Five—To see what sum of money the Town will
vote to raise for the Support of the Common Schools

Article Six-To see what sum the Town will vote to
raise for High School Tuition.

Article Seven-To see what sum the town will vote to
raise for Repairs and Insurance on School Buildings

Article Eight-To see what sum the Town will vote to
raise for Free Text Books.

Article Nine-To see what sum the Town will vote to
raise for School Supplies.

Article Ten-To see if the Town will vote to raise a
sum of money for purchase of School Flags

Article Eleven—To see if the Town will vote to raise
the sum of One Hundred Seventy-five Dollars for salary
of Superintendent of Schools.

Article Twelve—To see what sum of money the Town
will vote to grant and raise for the Repair of Roads and
Bridges.

Article Thirteen—To see what sum of money the Town will vote to pay to the Road Commissioners per day for their services, and fix the price per hour for labor on highways.

Article Eighteen—To see if the Town will vote "yes" or "no" on the question of raising money necessary to entitle the Town to receive State Aid as provided in Chapter 25 and Section 19 of the Revised Statutes of 1916.

Article Twenty-five-To see if the Town will vote to raise a sum of money to be used in payment for services of out-of-town Fire Companies.

Article Twenty-six - To see if the Town will raise money to provide for the services of a Public Health Nurse, or take action thereon. This action is made legal by the Maine Legislature of 1925; see Section 58, Chapter 140 of the 1925 Statutes.

Article Twenty-seven-To see if the Town will vote to raise Ten Hundred Fifty Dollars to pay note and interest coming due on tractor and snow plow.

Article Twenty-eight-To see if the Town will raise a sum of money to reduce the indebtedness.

Article Twenty-nine-To see if the Town will vote to authorize the Selectmen to purchase for the purpose of a Gravel Pit, certain real estate located in Kennebunkport, York County, Maine, and bounded and described substantially as follows:

A certain lot or parcel of land with the buildings thereon situated on the easterly side of the road leading from Biddeford to Beachwood, in said Kennebunkport, bounded and described as follows: Beginning on the easterly side of said road and at the southeasterly corner of the parcel hereby conveyed; thence running about northeast-

erly by the land of one Sullivan to a corner and land now or formerly of one Fogg; thence running northwesterly by said Fogg land to a corner and at land of one Knolt; and thence southwesterly by said Knolt's land to said road; and thence about southeasterly by said road to the point of beginning.

Also a parcel of land on the opposite side of said road, bounded by said road leading to Kennebunkport, by land of said Knolt, and by land of James H. Fogg, now or formerly, excepting a right of way called Benson road.

And if so, to see what sum of money the Town will raise to pay for the same.

Article Thirty—To see what sum the Town will vote to pay for the collection of taxes.

Article Thirty-one—To see if the Town will vote that for the purpose of procuring a temporary loan to and for the use of the Town of North Kennebunkport, to pay the indebtedness of said Town, due or to become due during the present municipal year, to be paid out of money raised by taxation during the present municipal year, the Town Treasurer be and he is hereby authorized and directed to borrow from time to time a sum or sums not exceeding in the aggregate Ten Thousand Dollars, and to execute and deliver the note or notes of the Town therefor, signed by the Town Treasurer and countersigned by the municipal officers of the Town.

Article Thirty-two—To see if the Town will vote to accept the list of jurors as prepared by the Selectmen.

Article Thirty-three—To act on any other business which may legally come before said meeting.

The Selectmen hereby give notice that they will be in session at the Town House at nine o'clock in the forenoon of the day of said meeting, for the purpose of revising and correcting the list of Given under our hands at North Kennebunkport this twenty-, fifth day of February, A. D. 1932.
