January 11, 1961 marks the completion of one year in the new Arundel Elementary School. The improved facilities have contributed greatly to the quality of instruction. I wish to congratulate Principal Clara Stone and her faculty on the manner in which the school has been conducted, and the contribution they are making to the education of the children of Arundel.

I wish to thank the Mothers' Club for their interest and effort in promoting projects for the benefit of the school. I hope that their interest in promoting a school lunch program will find ways and means to provide such a program beginning in September. This activity operated under the State School Lunch program and with Federal subsidy and surplus commodities, can be operated without any cost to the Town, as is the case in school lunch programs all over the country. It will be necessary for the Club to raise some money for equipment, which effort is already underway.

Much credit should be given to the Mousam Lodge No. 26 I. 0. 0. F. for their interest in providing playground equipment for the school yard.

Although the grounds have been rough graded, with very little money and labor, the yard around the school could be made attractive. I hope that something of this nature might be done this Spring and Summer.

The improved facilities assure better elementary education and better preparation for education beyond the eighth grade. The new school is an outstanding asset to the Town, not only for the purpose of educating the children of the Town, but also as an indication that the Town intends to keep pace with the progress that is being exhibited in all fields of endeavor, as we enter the new decade of the 1960's.

# Annual Report of Public Health Nurse Arundel — 1960

Public health, in simple terms, is the sum total of the health of individuals and families living in a community. An organized program for public health is one that offers those individuals and families every possible chance of living and enjoying life, free from the handicaps of preventable disease and disability. In more formal terms, the objective of a public health program is to bring to all the people the benefits of modern medical and related sciences including the care and rehabilitation of the sick and disabled, the promotion of healthful living, and the prevention and control of disease.

A number of people are involved in the attaining of this objective. All together they make up a "health team". The public health nurse is an essential member of this team. She shares in planning and action with other workers in the fields of health, education, and welfare; with physicians, hospitals, clinics; with school personnel; with citizen groups. One of her important functions is coordination with the others involved to provide public health services to individuals, families and community. Citizens of the community are also essential members of the health team. Alert to the health needs of their community, taking their share of responsibility to meet these needs, their contribution as health workers is indispensable to the effectiveness of the public health program. A vital, dynamic, working "health team" in the local community strengthens the public health not only of that community, but also of the State and the Nation.

Health is something that all men desire and there is no limited supply for which nations must compete. Community health, in its simplest terms, is the sum total of the health of individuals and families living in the community. The achievement of good health is, in the last analysis, a fundamental responsibility of every individual.

The Public Health Nurse is in a unique position to discover the health needs of the community. Her job is to promote health, prevent disease and deformity, and give nursing care to the sick. Everything we do to assure a healthy start in life improves a child's chance of health in maturity.

Visits are made to expectant mothers to encourage them to seek early medical care and follow the physician's recommendations. Infants are visited as soon as possible following discharge from the hospital to help with health and feeding problems.

Child Health Conferences were held monthly in the new school starting in March with a total attendance of 88. Immunizations against diphtheria, whooping cough, tetanus and polio and smallpox vaccination are available at these conferences. It is important to immunize babies early as that is the period when protection is most needed.

This year, for the first time, I participated in pre-school registration. This gave me an opportunity to interview each mother about the child's health history and immunizations and start the health record. Close cooperation between home and school will help to protect and improve the health of the children. Good control of communicable diseases can only be achieved if home and school work together.

Eye rechecks were done on 31 pupils referred by the teachers. Many of these were found to have defects which required further care. Parents were notified and in some cases assistance was given in making plans for correction. As a result many children have obtained the glasses they so badly needed. In October audiometer tests were done on all first grade children and referrals from other grades.

A polio clinic was held on January 26th, 1960, and a total of 110 inoculations were given:

Polio—first 4
second 1
third 10
fourth 95

In June following the Child Health Conference 20 school children received their fourth polio inoculation and one received the second

On October 27th a polio clinic was held for adults with a total attendance of 34. Vaccine for this clinic was supplied free of charge by the Department of Health and Welfare. A follow-up clinic is now being planned for January 10th, 1961 from 6-6 P.M. following the regular Child Health Conference. Since good nutrition is such an important factor in total health, we are now hoping to have a hot lunch program in the school. This could be very valuable, not only in providing the noon meals, but could also be used as a teaching tool for good nutrition. This program requires citizen support and understanding. Your local community group and health council have devoted a great deal of time and effort towards projects to raise money for equipment to make this program possible. They

can not carry the burden alone, however, since their members are limited. I would like to take this opportunity to invite the fathers to these meetings since they are parents too and they would have a better understanding of what this group is attempting to accomplish. I believe the work of the fire auxiliary is equally as important since it is a safety measure.

Arundel may be proud of its achievements in the past year. Much remains to be done, but any program that is static is not progressive.

I wish to take this opportunity to thank everyone who have given their support in any way. I am especially grateful to the selectmen, health officer, principal, teachers, members of the community group and health council and to the kind hearted people who so graciously provided volunteer transportation to clinics for needy cases.

#### **COMMENTS**

#### **CASH**

The cash balances, as noted in the balance sheet, were reconciled with the bank statements and a written confirmation of the balances was made.

#### UNCOLLECTED TAXES

A percentage of the uncollected taxes, as shown on the collector's records at December 31, 1959, and unpaid tax liens, were verified by written confirmation with the taxpayer.

#### SPECIAL FUNDS

Cemetery Trust Funds and the Special School Building Fund were found to be on deposit in properly designated accounts and were verified by written confirmation with the several bank depositories.

#### **GENERAL**

The procedure for keeping the municipal records of the town officers was examined, and found to be adequate, and in compliance with the General Laws of the State of Maine, as approved by the State Department of Audit.

#### SCOPE OF AUDIT

This audit was made as required by the State Department of Audit, Chapter 405, Section 26, of the General Laws of 1957.

Records were checked to determine the accuracy of recording cash transactions. The system of internal control was reviewed as to the handling of cash and other matters of financial concern. External verifications, on a test basis, were utilized to determine the correctness of recorded assets and liabilities.

Receipts, vouchers and cancelled checks were examined, for authenticity, for a selected period. Bond and insurance coverages were examined. Excise tax collections for a selected period were verified with copies of the receipts retained by the Tax Collector.
