Report of Superintendent of Schools

To the Honorable Board of Selectmen of North Kennebunkport. Following is my fifth annual school report:

As the effects of the World War pass away, as unemployment ceases, as agriculture and other kinds of business become somewhat stableized, the schools should improve.

This will be the case if the co-operation that always has been exhibited by the American people shall continue. Of its continuance, I have no doubt. The opportunity at least for education must be given every person between the ages of 5 and 21. It is better than any other investment that can be made. "Dirigo" is the motto of Maine and if the state does lead, it must be by the force of its towns and cities.

Let us not be the last in the line. Education is the greatest

Americanizing power yet devised.

Quite an advance has been made toward putting the text books in a uniform arrangement. Text books are among the most important of the tools used by the teacher. Worn out, soiled, or antiquated books do not appeal to teacher or scholars. There is much to be said in favor of Free Text Books, but an entirely new set should be furnished with greater frequency than has been customary in the past. Some books that are good text books today may be out of date in three or five years from now. New discoveries and inventions have to be reflected to some extent in literature. Following are the text books now in use: Frey Atwood Geography—a two book series.

Wentworth Smith Essentials of Arithmetic—a three book series.

Conn & Holt Physiology & Health—a two book series.

Modern English by Emerson & Bender, The Quincy Word List by Dr. Parlin.

The Beacon system of reading has been introduced so far as the text book appropriation permitted. A variety of readers has been in use—both old and new. Montgomery Series of United States is used. Reference books are very noticeable by their absence. Globes and maps seriously need renewing in many cases. Copies of the History of Maine should be added to the number already on hand as soon as funds permit.

Physical Exercise

The state law of 1919 requires towns "to make provision for instruction to be given to pupils in all public schools in personal hygiene, community sanitation and physical education, including recreational exercises. Clark's Physical training is used as a handbook for teachers who are giving a certain amount of time to physical exercises. This, however, only covers the minimum requirements and it is very desirable for pupils to be examined annually by some physician. Perhaps some arrangement could be made with a local physician

A new law was framed in 1921 for the improvement of sanitary conditions in school building toilets. A part of Section 2 is as follows: "On and after September, 1924, all school buildings shall be provided with toilet facilities that shall be installed in such manner and location as to insure privacy, cleanliness and supervision by teachers.." Then follows the minimum requirements (See Sec. 2, a, b, c, Chap. 33, P. L. 1921.)

Need of Wells

The necessity for pure water to use in homes is everywhere recognized by people. It is vitally important at school. Provision should be made for school wells as rapidly as possible. The Burnham and Durrell schools are in urgent, need of attention.

Teachers were employed in 1920-1921 as follows: At the Burnham school Florence M. Walker was employed.

Mildred L. Day taught the Durrell school and Mildred H.

Blake the North Chapel school. The schools were continued a period of thirty-five weeks.

I note from the Score Card issued by the state department for a standard rural school, items count as follows:

I—Grounds, 15 points. II—Building, 50 points. III-Equipment, 45 points. IV—Outbuilding, 15 points. Total, 125 points.

While there may not be many schools up to the standard, every community should try to "go over the top" as the expression is.

WARRANT

For Town Meeting—1922

STATE OF MAINE.

County of York, ss:

To Herbert W. Huff, Constable of the Town of North Kennebunkport, in said County, Greeting:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the said Town of North Kennebunkport, qualified by law to vote in town affairs to assemble at Town House, in said town, on the 6th day of March, 1922, at ten o'clock in the forenoon, to act on the following Articles, to wit:

Article One—To choose a Moderator to preside at said meeting.

Article Two—To see if the town will vote to dispense with the check list at this meeting.

Article Three—To choose all necessary town officers for the ensuing year.

Article Four—To see how much the town will vote to grant and raise for the support of common schools.

Article Five—To see if the town will vote to grant and raise the sum of three hundred and fifty dollars (\$350) for High School tuition.

Article Six—To see if the town will vote to grant and raise the sum of two hundred dollars (\$200.00) for repairs and insurance on school building's.

Article Seven—To see if the town will vote to grant and raise the sum of fifty dollars (\$50.00) for free text books.

Article Eight—To see if the town will vote to grant and raise the sum of one hundred dollars (\$100.00) for salary of Superintendent of Schools.

Article Nine—To see if the town will vote to grant and raise the sum of twenty-five dollars (\$25.00) for school supplies.

Article Ten—To see what action the Town will take to provide water for the schools, and raise money for the same.

Article Eleven—To see what action the Town will take for the improvement of sanitary conditions in school building toilets, as required by law and raise money for the same.

Article Twelve—To see what sum of money the town will vote to grant and raise for the repair of roads and bridges, and see what sum of money shall be paid to the road commissioners per day for their services, and fix the price per hour for labor on highways.

Article Thirteen—To see if the Town will vote to repair Durrell bridge, so-called, and raise money for the same.

Article Fourteen—To, see if the town will vote "yes" or "no" on the question of appropriating and raising money necessary to entitle the town to State aid, as provided in Section 19 of Chapter 25, of the Revised Statutes of 1916.

Article Fifteen—To see if the town will appropriate and raise the sum of \$533.00 for the improvement of the section of State Aid road as outlined in report of the State Highway Commission, in addition to the amounts regularly raised for the care of ways, highways and bridges; the above amount being the maximum which the town is al-

lowed to raise under the provisions of Section 18, Chapter 25, of the Revised Statutes of 1916.

Article Sixteen—To see what sum of money the town will vote to grant and raise for the support of the poor.

Article Seventeen—To see what sum of money the town will vote to grant and raise for the payment of snow bills.

Article Eighteen—To see what sum of money the town will vote to grant and raise for the contingent expenses.

Article Nineteen—To see if the town will vote to accept the list of jurors as prepared by the Selectmen.

Article Twenty—To see if the town will vote to authorize the. Treasurer to borrow money when so directed by the Selectmen.

Article Twenty-one—To act on any other business that may legally come before said meeting.

The Selectmen give notice that they will be in session tor the purpose of revising and correcting the list of voters at Town House at nine o'clock in the forenoon on the day of said meeting.
